In reference to the subject cited above and your conduct on 31.08.2024, a group of students led by you stopped the programme of Freshman Social which was to be held in the College premises. All the set was ready including stage, pandal, sound, musician and artist. Students were present in the pandal to participate and enjoy the programme, but the students led by you possessed the stage, captured the speaker, started shouting against the College Authority and declared not to allow for the programme.

As such you have been alleged with the following charges against you -

- 1) On 31.08.2024, a group of students led by you blocked the stage, shouting and screaming in the microphone, behaved indecently and instigated the other students against the College Authority and thereby polluted the atmosphere of the College.
- 2) You broke the peace and tranquility of the College and spoiled the name and fame of the College.
- 3) Your act and conduct was absolutely indiscipline and hostile in nature.
- 4) You behaved indecently with the Principal i/c in the office of the Principal.
- 5) You and the team lead by you broke the spirit and enthusiasm of all the students of the College who came to participate and enjoy the programme. In addition to this, you wasted around Rs.90, 000/ of the College which was spent in the name of Freshman Social.
- 6) Being the Vice-president of the Executive Committee of TLCSU, 2023-24, you broke the "Oath" taken during the Oath Taking Ceremony by exhibiting violent conduct against the College.
