### IMPORTANT NOTICE

It is for general information to all the students of Tezpur Law College that as per the Gauhati University Regulation and Syllabus for LL. B & BA, LL. B, "A candidate must pass all his/her semester examinations including the 'back' and 'betterment' chances within 5 (five) years in 3 yr. law course & within 8 (eight) years in 5 yr. integrated law course from the date of admission to the first semester. A candidate will get a maximum of 3(three) chances to clear a particular semester. Be it clarified that a candidate not appearing in any examination due, shall lose that particular chance allowed to him or her."

AND

**Maximum of 3 (three) theory papers may be allowed as 'back' papers in a particular semester** for 3 (three) yr. law degree course as well as 5 (five) yr. integrated law degree course. A candidate will be allowed to clear his or her back paper or papers within the prescribed limit of 5 (five) years in 3 yr. law and of 8 (eight) years in 5 yr. integrated law degree course from the date of admission in the first semester.

The Gauhati University Regulation and Syllabus is in conformity with the Bar Council of India Rules (under the Advocates Act, 1961) PART- IV and as approved and adopted by the Bar Council of India at its meeting held on 14<sup>th</sup> September, 2008 vide resolution No. 110/2008 (Rules under Section 7(h) & (i), 24(1) ©(iii) and (iii)(a), 49(1) (af), (ag) and (d) of the Advocates Act, 1961.
