## NOTIFICATION NO - 141

### Regarding 4<sup>th</sup> Attempt of Arrear Papers of LLB Programmes

1. 4<sup>th</sup> Chance (over and above one regular and two arrear) covering odd and even semesters shall be allowed. It will be for the last time and only applicable for the students facing this issue during 2024-25 session. This will not be applicable later.
2. All students who have completed maximum programme duration (5 years for 3 year LLB and 8 years for integrated LLB) will not be eligible for this provision.
3. Gauhati University shall not be responsible for any difficulty faced by the students in obtaining professional licenses as a consequence of obtaining LLB degrees with support of the above-mentioned provision (i.e clearing 3-year and 5-year Integrated LLB programmes with fourth chance for arrear papers).
4. Principals of colleges shall prepare a list of such students, and forward these to the office of the COE.
5. The date of examination form fill-up shall be extended upto 16 December, 2024.
6. The above shall be relevant for the last time. It cannot be cited as precedence for obtaining such relaxation hereafter or in the near future. The existing ordinance/regulation of 3Yrs. and 5Yrs. Integrated LLB programmes shall be applicable.
