**AMENDMENTS**  
**ON CERTAIN PROVISIONS OF TLCSU CONSTITUTION**

1) ARTICLE- 2 : AIMS AND OBJECTIVES

(a) - "To promote all round development - Mental, Physical and Cultural of the members of this College in General and the students in particular". The word "**Social**" **has been added** with Mental, Physical and Cultural,

2) ARTICLE- 9 : DUTIES OF THE SECRETARIES

( c )– When the post of GS is vacant ;-- " When the General Secretary resigns or vacates his office either by transfer, resignation or removal or death, then the President shall appoint one of the Assistant General Secretary to function as General Secretary till election of a new General Secretary with due consultation with the EC". **The word 'one' has been omitted** as there is only one portfolio of Assistant General Secretary in TLCSU.

3) ARTICLE -10: DUTIES OF THE TEACHER IN -CHARGE --

iii. "Recommend such expenditure to the Principal, as are requisitioned by the Secretary concerned, permissible under the budget". **The content has been changed** as "Budget will be fixed and allocated by the Principal in consultation with the President, Governing Body of the College to each Secretary of the Executive Committee for a year and within that budget, Sectional Secretaries will arrange the events. Accordingly the funds will be released to the concerned Teacher In-Charge".

4) ARTICLE -11: REMOVAL --

"Any act of indiscipline against the College Authority. Such action shall be taken by the College Authority in consultation with the President, Governing Body and with communication to the President, TLCSU". This portion **has been added**.


5) ARTICLE -12: MEETINGS -

Clause (a) -- "There shall be at least two General Body Meetings of the TLCSU in a year". **has been changed** as -- 'The General Body meeting may be invited either by Authority of the College or by students on any serious emergency matter.'

Clause (f) -- "For each meeting of the General Body a prior permission of the Principal is mandatory". also **has been changed** that -- 'for each meeting of the General Body a prior permission of the Principal at least 5 days is mandatory if it is convened by students. '


6) ARTICLE -16 : FILLING OF VACANCY -

One new Clause i.e. Clause 16 (c) is **newly inserted** along with (a) & (b) with the content -- "If no one contested in any portfolio/ no one qualifies for the candidature, then through a general notice inviting applications from the interested candidate to fill up the vacancy. The Principal will appoint the portfolio by selecting suitable candidate from the interested applicants".
